

The foregoing Matter of State Arrearage having been heard by the Court, it is hereby Ordered that:

1. As of April 30, 1986, an arrearage of \$12,014.45 exists.
2. In addition to the State contributing \$590.00 per month for the support of the children, the Plaintiff Mother shall pay \$12.00 per week, not to exceed more than \$50.00 per month, toward child support to the State.
3. The Defendant shall pay the sum of \$25.00 per week, \$12.50 per child, and an additional \$12.50 on the arrearage, subject to review on September 15, 1986.
4. An immediate Wage Execution shall enter.
