

Charles Lake's Shorten Brief for both child support cases using existing Exhibits dropped off on March 2, 2022.

I have two cases that should be heard at the same time. To make sense and to make it go faster let me condense both cases so maybe they will be heard together, **Because the final bill put them together.**

Let us look at the **final bill** in 1994 which is **Exhibit J of original Brief**. It states that I owed \$524.01 for the child support of my oldest children at the time the last child (Rebecca the youngest) was emancipated (became 18 years of age or was out of school) which was true on both counts.

And this last bill also states that I owed \$336.24 on the child support for Steven or the Cynthia Layden v. Charles Lake **DBD-FA- 144018720-S**

Case 1: Edna Lake v. Charles Lake or as the court has it, Linda Lake v. Charles Lake DBD-FA-85-0287428-S addresses the oldest children.

In this case there are two children Charles Lake III and Rebecca Lake who turned 18 and were out of school before I was sent the last bill in 1994 for \$524.01.

So, with no children on child support how and why was I charged from 1994 to present for child support that has been PAID? From \$524.01 to \$17,100.82 with no child support owed after 1994.

10/4/2003 I received a bill from child support enforcement for a total of \$11,284.45! This was sent to my mother's house Edna Lake. **Exhibit X of original Brief**

12/30/2006 I received a bill from child support enforcement for a total of \$17,908.67! **Exhibit Y of original Brief**

8/31/2014 I received a bill from child support enforcement for a total of \$17,100.82! **Exhibit Z of original Brief**

How does a bill grow after it has been paid for from 1994 at \$524.01 to 2014 to \$17,100.82?

Case 2: Cynthia Layden v. Charles Lake DBD-FA- 144018720-S

In 1982 my son Steven was abandoned by Cynthia at his grandparents (Cynthia Layden parents) at the same time my daughter Tiffany was abandoned at Cynthia's apartment in Mill Ridge. Tiffany went into foster care after being found. Grandparents did not want Tiffany at they house.

DCYS refused me visitation of Steven because the grandparents would not allow it, But, in 2/27/1984 (after working for almost 2 years with DCYS) I was given temporary custody of Tiffany and on 4/21/1986 I received Full and Sole custody of Tiffany from DCYS and the State of Connecticut. They, DCYS, still refused to let me have visitation or Steven's sister Tiffany to have visitation because of the grandparents.

On 7/7/1987 Cynthia died (this is when support should have stopped), the grandparents started adoption proceedings and in 7/10/1989 the grandparents won the adoption which also should have stopped the Child Support Charges to me Charles Lake. But, according to Connecticut

records, which is in the brief and exhibits, it shows that the State kept charging me until and maybe even beyond 1/5/1991 (**see Exhibit V of original Brief**). This is 29 months after Cynthia died (or an overbilling of approximately \$1,247.00) and 17 months after Steven was adopted (or an overbilling of approximately \$731.00).

It does not end there: 1/31/2004 I received a bill from child support enforcement for a total of \$524.01!

7/17/2004 I received a bill from child support enforcement for the same amount of a total of \$524.01 for the second time! (C50_Layden_overdue_7_17_2004.pdf)

12/30/2006 I received a bill from child support enforcement for a total of \$4,394.96! (C51_Layden_Overdue12_31_2006-1.pdf)

8/2/2014 I received a bill from child support enforcement for a total of \$4,166.81! (C52_ArreargeCindy8_2_2014.pdf)

How does a bill grow after it has been paid for? From 1994 at \$336.24 with a almost 2 or 3 year overbilling to 2014 being 4,166.81 (while overbilling this account until 1991)?

I am hoping this will help the Magistrate hear both cases on 7/13/2022 so I can be finish with this.

Please STOP taking my Social Security for bills that have been PAID (but double billed and Over Billed by the State)!!

I would like my money and my life back after being on the dead-beat dads list for all these years. I cannot travel and have had other rights taken because of a corrupt child support section of the State.
