Legislation in the U.S. Senate to propose a Parental Rights Amendment to the U.S. Constitution has officially received a bill number: **Senate Joint Resolution 36**. “Michigan code 380.10 was the first known parental rights statute in the country. Adopted in 1996” and the list is growing of States that are starting to “**preserve a parent’s “fundamental right and duty to make decisions concerning [the] care, custody, and control” of their children.**” Maybe Connecticut should take a look at this trend!

The State of Connecticut can never give me back the memories or the time I would have had with my children or the Freedoms that I should have had as an American citizen. According to “**Griswold v.
