I understand that we are in the middle of an epidemic but even through bad things are happening to other people this bad thing has been happening to me for 42 years and to my 2nd family for going on 39 years.

Liz I sent you information on my problems with the State of Connecticut Child Support Enforcement on April 2020. I also spoke to you in the office and gave you information on this issue in 2019. You said that you gave it to HHS.

HHS is not going to look at this as a priority because they are understaffed and it will take many more years before they may or may not look at this.

What I need is a more aggressive approach from your office. What I need is for your office to contact the State of Connecticut's Governor Ned Lamont and make him aware of my situation.

Especially since the State of Connecticut has taken both my wife's and my stimulus \$2400.00 towards this fraudulent bill (see attached). My wife Joann is NOT the mother of the children the State of Connecticut is looking for payment of child support under fraudulent unlawful pretenses.

The letter I wrote to Senator Gillibrand. Please refer to the highlighted sections to form questions to Connecticut's Governor Lamont like:

- 1) If John Dillon did a complete audit in 2009; Why was the court surprised in 2014 when I had several other court documents that they did not have including the Dissolution of my Marriage?
- 2) Why after 1993 the total for Charles (support stopped on his 18th birthday, 1/25/1993) & Rebecca (support stopped on his 18th birthday, 1/13/1994) went from \$336.24 to \$11,284.45 in 2003 to \$17,908.67 in 2006 to \$17,100.82 in 2014?
- 3) Why after 2004 did the Total for Steven go from \$524.01 in January to July of 2004 to \$4394.96 in 2006?
- 4) Steven's child support should have been stopped 5/2/1988, when the adoption was complete to his grandparents but it was never stopped until 1/5/1991. Why was it too late for the court to correct their

mistake?

5) Why didn't the audit that the State of Connecticut did in 9/24/2014 show any IRS seizures and why wouldn't the court except the IRS seizures that I could supply?

1989 the State of Connecticut seized \$944.30 of Charles and Joann Lakes (mine and my wife's joint) IRS return. 1993 is confusing but the State of Connecticut either seized \$1,364.74 or \$606.05 or \$758.69. 2002 the State of Connecticut seized \$543.00 even though Joann was the primary source of income and filed an injured spouse form, because I (Charles Lake) have been on SSD because of severe injury since 1992.

Please help bring these questions to the attention to Connecticut's Governor Lamont and clear my name to get me off the Dead Beat Dad's List where I do not belong.

Don't you think that Connecticut's Governor Lamont should know that the Connecticut Child Enforcement & Support Systems and Courts are all Corrupt?

Connecticut's Governor Lamont should answer these questions and bring these corrupt systems to an end!
