Senator Gillibrand was Congresswoman Gillibrand when she told me she could help me with the issue that I was having with the Child Support Enforcement of Connecticut. Congresswoman Gillibrand's Legal Assistant Benedict McCaffree asked me to first contact Child Support Enforcement of Connecticut and try to work things out.

I asked for a hearing in Danbury Superior Court and was given a date. I took the court date, letter from John Dillon and my Dissolution of Marriage with supporting documentation to see Mr. McCaffree who was now working for Congressman Murphy and explained that the review John Dillon did was not complete. In 2014 I went to clear my name at the Danbury Child Support Enforcement Court and you can see what happened in the letter I recently wrote to President Trump (see Attached) The website that explains everything from the start 1976 with all documentation including court papers is. <http://www.comfortncolor.com/CT%20Book/DBook1WCover-test.htm>

In 2015 I went to Congressman Gibson's Office with all of my documentation and showed how the U.S. Department of Justice (US Attorney Deirdre M. Daly) was investigating the Connecticut Courts including Department of Support Enforcement courts for Corruption. Congressman Gibson's Office wrote a letter on my behalf. Congressman Gibson's Office received a reply from the U.S. Department of Justice. I filled out the paperwork and sent it in. I never received a reply and was not able to get a response to other contact with the DOJ. ### Conclusion:

The State of Connecticut helped my Mother take my children in 1976 without an investigation or cause. In 1986 after receiving full custody of Tiffany after an aggressive custody study by Janice Quinlan who wrote a letter on my behalf for the judge at my divorce who awarded custody to me (Charles Lake) but, the State was to do another custody study. Leslie Raider the person the State of Connecticut charged with doing the custody study refused to do the custody study. This lead to the 1988 decision by the court where Leslie Raider was the prosecutor and would not let me have an Attorney or speak or show any documentation to the judge; which is the decision John Dillon's letter refers to that exonerates the Corruption of the past for the State of Connecticut.

Did the State make a mistake in 1976 by not doing an investigation and covered it up in 1986 by not doing the custody study thinking that 1988 decision would put an end to the question of Corruption or is there something more sinister going on?

1) **President Donald Trump.pdf** : A letter that I sent to President Trump which explains much more. This letter was sent by way of The Fathers Rights Movement and The Connecticut Fathers Rights Movement by David Vesper

2) **Lt Governor Susan Bysiewicz.pdf** : An E-mail that I sent to Lt Governor Susan Bysiewicz Office (VIA-Adam Joseph adam.joseph@ct.gov e-mailed Oct. 2, 2019) with no response which explains how after my children Charles (was 18 in 1/1993) and Rebecca (was 18 in 1/1994) were emancipated the total amount owed went up as time. It went on from \$336.24 in 1993 went to \$11,284.45 in 2003 to \$17,908.67 in 2006 and \$17,100.82 in 2014. It also shows that the State was charging me for support 18 months after Steven was adopted in July of 1989 and the amount also went up over time from \$524.01 in 2004 to \$4,394.96 in 2006 and 2014. 3) **Edna.pdf** : The letter that I recently wrote and mailed to my mother Edna Lake who stole my children when I was asked to let bygones be bygones so she can die in peace. I have not heard back from any family member.

4) **Office of Governor Ned Lamont.pdf** : Letter to Connecticut Governor Lamont asking him to Stop the harassment and Stop taking my Social Security Disability for a fraudulent bill.

Senator Gillibrand Please contact Governor Lamont and ask that this madness stop and give me back my life as you can see the State of Connecticut has a problem and I have Been a Prisoner to this State even though I was not behind bars but, in many ways I have. I did Nothing Wrong!!
