I was referred to you by the U.S. Department of Justice.

Attached is a letter to the New York Attorney General's Office that clearly shows the fraud and embezzlement to independent contractors/ small businessmen for Workman's Compensation insurance the company never had. This fraud and embezzlement effected independent contractors/ small businessmen in six states.

The company is trying to have my personal injury case dismissed by using the Pennsylvania's Workman's Compensation decision where the evidence shown (3 letters selling Workman's Compensation and payment of injury and other documentation) was, Not Admitted by the judge. Therefore, using the corrupt decision of that judge to hide the embezzlement and fraud and use it as a defense in my personal injury case.

Because of this fraud the State of New York has a lien against my personal injury case to retrieve the money they expended for my heath care and supporting my family.

Other ways that show this judge and court was bias to my case:

The judge refused to let me fire my attorney (Mr. Diorio) knowing my attorney would not talk to me.

The judge guaranteed that I would be reimbursed for renting a vehicle and traveling to Pennsylvania to submit to an examination by MPC Trucking doctor. I sent a letter to the judge (<a href="http://www.comfortncolor.com/HTML/OSHA-Courts/Nyce.htm">http://www.comfortncolor.com/HTML/OSHA-Courts/Nyce.htm</a>) never received a response or reimbursement.

The court would not let me change my address saying that only my attorney could change my address with the court, knowing that my attorney would not talk to me. Mr. Diorio also misdirected this case by not filing a change of address I had sent to him. This is how the court would send the Judge's decision to the wrong address and I was unable to appeal within stated time; "IF YOU DO NOT AGREE WITH THIS DECISION AN APPEAL MUST BE FILED WITH THE WORKERS' COMPENSATION APPEAL BOARD WITHIN 20 DAYS OF THE DATE OF THIS NOTICE."

The Judge's decision was bias because he added his opinion; he stated, "The Judge finds that Claimant was fully recovered from the injury no later than May 18, 1992". The judge knew that I was on Social Security Disability since 1992! This judge's medical opinion, even though he is not a Doctor has hindered my personal injury case because the New York court is using it as fact to limit my case against this company.

This judge made these decisions to aid a corrupt company!

MPC Trucking would haul food product in the same trailers that they would haul asbestos (and other toxic material) knowing that it was in violation of the Law (Hazardous Materials Transportation Act of 1974
