

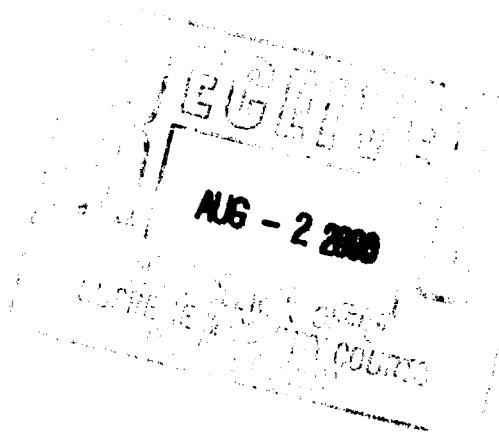
I need this information:
