In speaking to your office on Wednesday, March 26, 2008 they informed me that you do not prosecute companies for fraud and embezzlement of independent contractors/ small businessmen that I would need a lawyer to handle that.

However, I believe that MPC trucking individualized me in the letters that they used to sell the Workman's Compensation Dated 1/7/91, 1/30/91 and 2/15/91. The letter of 1/30/91 is addressed to C. Lake not like the other letters 1/7/91 and 2/15/91which are addressed to owner-operators.

As you can see I never signed these letters! J Kot Assistant General Manager of MPC Trucking told me that he started taking the money out of my pay (even though I never signed these letters) for Workman's Compensation because I leased a truck from MPC Trucking and in return leased it back to MPC Trucking and they dispatched me therefore, MPC Trucking considered me an employee and I had to be covered by Workman's Compensation.

If you look at my invoices you will see were J Kot did the math, subtracting the Workman's Compensation from my pay and then he would initial it. Here are some of the invoices I am referring to that are on my website.
