County of Maui	means a bag that is made from noncompostable plastic or compostable plastic, and is not specifically
Ordinance No. 3587	designed and manufactured for multiple re-use.

Plastic checkout bag	
City & County of Honolulu	(1) Means a carryout bag that is provided by a business to a customer for the purpose of transporting
Ordinance No. 19-30	groceries, prepared food, or other retail goods, and is made from plastic and not specifically designed and manufactured for long-term re-use;
	(2) This term does not include:
	 (A) Handle-less plastic bags used by customers inside a business to package loose items, such as bakery goods, fruits, vegetables, nuts, ground coffee, grains, candies, or small hardware items;
	(B) Handle-less plastic bags used to contain or wrap frozen foods, meat or fish, flowers or potted plants, or other items to contain dampness;
	(C) Newspaper bags for home newspaper delivery
	(D) Laundry, dry cleaning, or garment bags
	(E) Bags sold in packages containing multiple bags intended for use as garbage, pet waste, or yard waste bags;
	(F) Bags used to contain live animals, such as fish or insects sold in pet stores; or
	(G) Bags used to transport chemical pesticides, drain-cleaning chemicals, or other caustic
	chemicals sold at the retail level; provided that this exemption shall be limited to one bag per customer.
County of Hawai'i	means a carryout bag that is provided by a business to a customer for the purpose of transporting
Ordinance No. 12-1	groceries or other retail goods, and that is made from non - compostable or compostable plastic and not specifically designed and manufactured for multiple re -use.

Plastic film bag	
City & County of Honolulu	(1) Means a plastic bag made out of thin flexible sheets of plastic with a thickness of 10 mils or less;
Ordinance No. 19-30	(2) This term does not include:
	(H) Handle-less plastic bags used by customers inside a business to package loose items, such as bakery goods, fruits, vegetables, nuts, ground coffee, grains, candies, or small hardware items;

Recyclable paper bag	
City & County of Honolulu	means a paper bag that: (1) is one hundred percent recyclable, (2) contains a minimum of forty percent
Ord. 12-8	post-consumer recycled content, and (3) displays the words "Reusable" and "Recyclable" in a highly
	visible manner on the outside of the bags.
County of Maui	means a paper bag that: (1) is one hundred percent recyclable, (2) contains a minimum of forty percent
Ordinance No. 3587	post-consumer recycled content, and (3) displays the words "Reusable" and "Recyclable" in a highly visible
	manner on the outside of the bags.
County of Kaua'i	means a bag that meets all the following requirements: (1) contains no old growth fiber; (2) is one
Ordinance No. 885	hundred percent (100%) recyclable overall and contains a minimum of forty percent (40%) post-consumer
	recycled content; and (3) displays the words "Reusable" and "Recyclable" in a highly visible manner on the
	outside of the bag.

Retail Establishment	
County of Kaua'i	means any commercial business facility that sells goods directly to the ultimate consumer, including, but
Ordinance No. 885	not limited to, grocery stores, pharmacies, liquor stores, "mini-marts," and retail stores and vendors
	selling clothing, food and personal items. Retail establishments shall not include fundraisers by
	organizations classified under Section 501(c) of the United States Internal Revenue Code or non-
	incorporated community booster organizations.

Reusable bag	
City & County of Honolulu	means a bag with handles that is specifically designed and manufactured for multiple reuse and is made
Ordinance No. 17-37	of: (1) cloth or other washable fabric; or (2) durable material suitable for reuse, including plastic that is at
	least 2.25 mils thick. After January 1, 2020, plastic film bags shall no longer be considered to be "reusable"
	bags."
County of Hawai'i	means a bag that is specifically designed and manufactured for multiple re -use and is (1) made of cloth or
Ordinance No. 12-1	other machine washable fabric or (2) made of paper specifically designed for multiple and long-term use.
County of Maui	means a bag that is specifically designed and manufactured for multiple re-use and is (1) made of cloth or
Ordinance No. 3587	other washable fabric, or (2) made of durable material suitable for reuse.
County of Kaua'i	means a bag with handles that is specifically designed and manufactures for multiple reuse and is made of
Ordinance No. 885	cloth or other machine washable fabric and/or is made of a durable material at least 2.25 millimeters
	thick and suitable for reuse.
