This is a Mass Tort, Not a Class Action

What's the difference?

In a mass tort, victims are treated as individuals and the specific merits of each claim are taken into consideration. In a class action, every victim has a similar injury and is treated identically.

The benefit of mass tort litigation is that plaintiffs have more power in settlement negotiations which ultimately lead to significantly greater payouts compared to class actions.

- Settlements and payouts tend to be significantly higher compared to class action awards
- Plaintiffs have more power in settlement negotiations

Victims getting what they deserve


2024 - 3M will begin payments starting in the third quarter to many U.S. public drinking water systems as part of a **multi-billion-dollar** settlement over contamination with potentially harmful compounds used in firefighting foam and several consumer products.

2023 - Chemours, DuPont and Corteva paid more than **\$1 billion** to settle the first in a wave of claims that they contaminated drinking water across the country with so-called forever chemicals.

PFAS Lawsuit Background

PFAS, which stands for Per- and Polyfluoroalkyl Substances, are a group of **chemicals** that have raised **serious health concerns** globally, particularly in **the United States**. The journey of PFAS litigation began as the **harmful environmental and health effects of these chemicals** became evident. Initially used in industrial processes and oil production for their resistant qualities, the reality of PFAS's persistence in the environment and **potential harm** came to light through scientific research.

Legal actions initially focused on industries and areas directly impacted by PFAS use. However, as the extent of **PFAS contamination** in the environment, especially in **water systems**, became clearer, the scope of lawsuits expanded. These mass tort lawsuits have unified
