# Asbestos Claim Payout Timeline

While the [asbestos claim payout timeline](#) will vary for each case, many victims **begin receiving compensation in as few as 90 days**.

Asbestos trust fund claims often provide victims with **much-needed compensation quicker** than a mesothelioma lawsuit because of how they're paid out.

## Asbestos trust funds review and pay out claims in two ways:

- **Expedited review:** If you meet certain requirements, you can receive a fixed amount of money from the trust fund. This helps victims get funds sooner.
- **Individual review:** If your case is more complex, administrators will carefully study your medical records and asbestos history. While these reviews take longer, they work to provide meaningful compensation for those with less straightforward cases.

The majority of asbestos trust fund claims undergo an expedited review, while only 2-3% of all claims undergo an individual review.

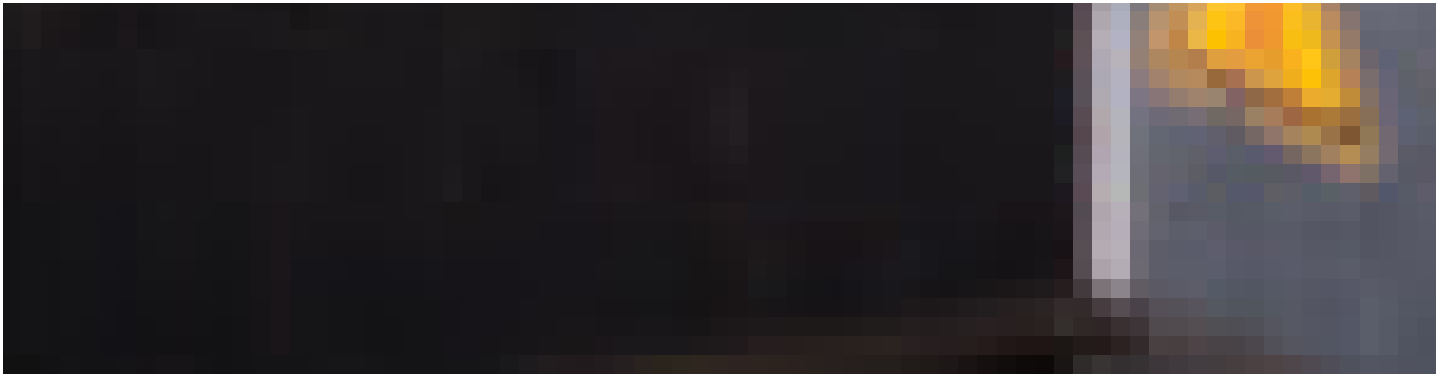

## How do asbestos trust funds work?

With asbestos trust funds, money has already been set aside for victims of mesothelioma and other asbestos-related diseases by companies that made products with asbestos and later declared bankruptcy.

Once your legal team files your claim, the trustees of the asbestos fund review your case to ensure you qualify and then offer you an asbestos payout.

Once approved, you should receive compensation within only a couple months.

## How long do I have to file an asbestos trust fund claim?

**You only have a limited amount of time to file asbestos trust fund claims** due to state laws called statutes of limitations, which restrict how long you have to take legal action.

## What is the asbestos trust payment percentage?

Asbestos trust payment percentages refer to **how much money a trust will pay out for each claim.**

In order to ensure current and future victims have access to this money, asbestos trusts can only pay out a portion of each claim.

The asbestos trust payment percentage fluctuates over time depending on how much money is currently in the trust, so it's important to [file your claim as soon as possible.](#)

## How are mesothelioma fund claims reviewed?

As part of the asbestos claims process, your lawyer will review your exposure information and recommend either an expedited review or an individual review of the mesothelioma fund claim:

- **Expedited Review:** Most trusts have determined a payout for those that meet basic requirements for approval of a claim — this means every claimant approved with the same disease gets the same mesothelioma trust fund awards (money).
- **Individual Review:** If our lawyers determine that you may be awarded more money based on the unique facts of your claim, they may recommend that you pursue an individual review. In this case, the trustee may award a higher amount than offered through the expedited review. This process can take longer, and it's possible the trustee may award less money than the expedited review.
