Mr. Bryant, I apologize for not getting back to you sooner. There is no one else to contact as I take care of the web page. This page has not been on my website for approximately 2 years; However, it is still on my server.

This is my story of how I was treated by the asbestos litigation Attorney's.

I believe it was in 2019 that I was diagnosed with asbestosis. In doing research on asbestosis, I was contacted by an asbestos litigator / law firm from Boston who said they could help me. After about a year of filling out all the forms and getting the paperwork done, I was told that this law firm could not represent me because I was not sick enough!?

I was also told that my case had to be refiled within two years otherwise I could not refile my case. This means I had to get sick enough to be accepted by the asbestos litigation committee. Even though I have documentation showing that I hauled asbestos out of the asbestos mines as shown on my website with documentation to prove it.

Here's the problem: I had to leave New York because my oxygen levels kept going down into the low 80s upper 70s which makes it very hard to think or function. The hospitals in New York run their Asbestos testing in the controlled environment which helps you breathe (air conditioned (not everybody has air conditioning)).

Now that I moved to the West Coast my oxygen level usually stays mostly at 96 even when I take a two mile walk which is a mile and a half further than I could in New York.

I do not want people that look at my website to think that they can file a claim with the asbestos litigation and then run into the same situation with not being sick enough!

What good is the money when you're next to being dead or dead it does not ease the pain of what you've been through.

If the asbestos attorneys that you deal with are willing to help me, I have no problem putting the Asbestos page back up and referring people to them.
